**NOTIFICATION**

Under the provisions of Department of Urban Development & Municipal Affairs and Department of Panchayat & Rural Development respectively, Government of West Bengal has authorized WBEIDC Ltd. (WEBEL) to give approval of building site and sanction of Building Plan for setting up of IT/ ITeS industry, Hardware industry and Electronics Manufacturing industry on the lands owned by and/or leased to the WEBEL, or to re-erect or make addition to and/ or alteration of Building which is being or to be used for Industrial purpose in the concerned Industrial Area including inspection of multi-storeyed buildings by Gazette Notification no. 548/MA/O/C-4/3R-4/2015 (Pt.-II) dated 10.08.2015 by Department of Urban Development & Municipal Affairs and Gazette Notification no. 3079/PN/O/I/1A-10/14(Pt-I) dated 01.07.2005 by Department of Panchayat & Rural Development respectively.

In order to facilitate online submission of application by the intending investor with the purpose of enabling Ease of Doing Business in the State of West Bengal, the following services namely; (1) Building plan approval for IT/ ITeS industry in IT/ITeS Parks, Hardware industry and Electronics Manufacturing industry on the lands owned by and/or leased to the WEBEL, or to re-erect or make addition to and/ or alteration of Building which is being or to be used for Industrial purpose, (2) Provision for online issuance of Certificate of Inspection and (3) Provision for online issuance of Occupancy cum Completion Certificate, shall be made available online with effect from 10<sup>th</sup> August 2017.

In this respect, the Governor is pleased to authorise WBIDC Limited under the aegis of the Department of Industry, Commerce and Enterprises, Government of West Bengal to provide the abovementioned online services in lieu of WBEIDC (Webel), until further orders. All compliance related to those services shall be met with by the WBIDC instead of WBEIDC, until further orders.
